Cowtown Days Eagle's Golden Egg Hunt

2018 Contest Rules

HOW TO PLAY:

1. Eagle's Golden Egg will be hidden in an actual location, and is located within a five mile radius of the Cowtown Days Grounds, Ellsworth, Kansas.
2. Eagle's Golden Egg Hunt (Contest) is sponsored by Eagle Communications, Inc. (Eagle). Eagle will pay a reward of \$125.00 to the individual or team that successfully finds and returns the 2018 Eagle's Golden Egg to be held in conjunction with the 2018 Cowtown Days, Ellsworth, Kansas.
3. **No Eagle's Golden Egg Hunt clues, nor the hiding place, require entry onto private property. Destruction of property and trespassing is not necessary and will not be allowed. Eagle's Golden Egg is not buried underground or hidden anywhere that would require destruction of property of any kind to get to it, and climbing will not be necessary.**
4. Be safe and play nice! Participants who engage in any unsportsmanlike, disruptive or abusive behavior will be disqualified, in our discretion.
5. The Contest begins on Wednesday, August 22, 2018 and ends at the time the official Eagle's Golden Egg has been turned in/ found and a winning participant has been determined.
6. Beginning Wednesday, August 22, 2018, two new clues will be published each day on www.eaglecom.net, the first clue by 9 a.m. and the second clue by 2 p.m.
7. The participant finding the 2018 Eagle's Golden Egg should follow the directions hidden with the Golden Egg. The finder or associated party may not disclose their finding through any communication source – verbal or nonverbal, including but not limited to Facebook and other social medias such as texting, messaging and etc. After the time an Eagle Communications Employee-Owner has communicated to the finder that he/she has not violated any rules and has in fact won the reward, the finder may then communicate the finding.
8. Arrangements for turning in the Golden Egg and receiving the reward, will be made through e-mail communication after confirming the Golden Egg find.
Reward for Eagle's Golden Egg is \$125 until Sunday, August 26, 2018. Should the Golden Egg not be found until after that date, the reward for Eagle's Golden Egg distribution will be as follows:
 - Monday, August 27, 2018 – Winner will receive \$75 & Ellsworth County, KS charity of the winner's choice - \$50
 - Tuesday, August 28, 2018 – Winner will receive \$50 & Ellsworth County, KS charity of the winner's choice - \$75

- Wednesday, August 29, 2018 – Contest will be closed and all reward monies will be paid out to a Ellsworth County, KS charity of Eagle's choice.

For payout of the reward, the chosen charity must be a recognized organization who is also currently 501(c)3 qualified with benefactors residing in Ellsworth County Kansas. Payout amounts will be based on the e-mail date and time.

ELIGIBILITY:

9. Contest is FREE and open to participation to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age or older by August 22, 2018, and has a valid state photo identification card. Any individual or team is eligible to participate in the Contest except for Eagle Communications, Inc.(Contest Facilitators) employee-owners or members of the Eagle Communication, Inc. Board of Directors and their immediate family (defined as spouse, parents, siblings, children, uncles, aunts, nephews, nieces, grandparents and in-laws, regardless of where they live) or members of their households; and Cowtown Days Committee members (Contest Facilitators). The Contest is subject to federal, state and local laws and regulations. It is not necessary to be a customer of Eagle Communications to be eligible to win.
10. Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Eagle will provide a Publicity Release, and the winner will be required to complete and return it before being awarded the prize.
12. Notification of participation to Contest Facilitators is not necessary.
